



Standards Revision Process Critical Fact Sheet March 2019

Overview/Background:

Senate Bill 1 (2017) called for the Kentucky Department of Education to implement a process for reviewing all academic standards and aligned assessments beginning in the 2017-18 school year. The current schedule called for one or two content areas to be reviewed each year and every six years thereafter on a rotating basis.

Adopted Standards – August 2019 Implementation

- Kentucky Academic Standards (KAS) for Computer Science
- Kentucky Academic Standards (KAS) for Mathematics
- Kentucky Academic Standards (KAS) for Health Education
- Kentucky Academic Standards (KAS) for Physical Education
- Kentucky Academic Standards (KAS) for Reading and Writing

Kentucky Academic Standards (KAS) for Reading & Writing and KAS for Mathematics:

- August 2017 – Teachers applied to be on the writing teams to develop the new KAS for Reading & Writing and KAS for Mathematics.
- November 2017 – Feedback was solicited on the current standards.
- January 2018 through June 2018 – Writing teams reviewed feedback and drafted new standards.
- Spring 2018 – Focus groups were convened to provide feedback on the drafted changes.
- May 2018 – Feedback was solicited on the newly drafted standards.
- June 2018 – Writing teams addressed final feedback and submitted completed draft document.
- July 2018 – Interim Joint Committee on Education provided feedback on the draft document.
- August 2018 – The draft document was heard before the Kentucky Board of Education for a first read.
- October 2018 - The draft document was heard before the Kentucky Board of Education for a second read.
- January 2019 – The draft document was presented to the Administrative Regulation Review Subcommittee (ARRS).
- March 2019 – The KAS for Reading & Writing and KAS for Mathematics are adopted into law.
- August 2019 – Implementation for KAS for Reading and Writing and KAS for Mathematics begins.

Kentucky Academic Standards (KAS) for Social Studies:

- January 2018 – Teachers applied to be on the writing teams to develop the new KAS for Social Studies.
- February 2018 – Feedback was solicited on the current standards.
- March 2018 through January 2019 – Writing teams reviewed feedback and drafted new standards.
- Summer 2018 – Focus groups were convened to provide feedback on the drafted changes.
- August 2018 – Feedback was solicited on the newly drafted standards.
- November 2018 – Writing teams addressed final feedback and submitted completed draft document.
- November 2018 – Interim Joint Committee on Education provided feedback on the draft document.
- December 2018 – The draft document was heard before the Kentucky Board of Education for a first read.
- December 2018 – Additional focus groups were convened.
- February 2019 - The draft document was heard before the Kentucky Board of Education for a second read.
- April 2019 – The draft document will be presented to the Administrative Regulation Review Subcommittee (ARRS).
- June 2019 – The KAS for Social Studies will be adopted into law.
- August 2019 – Implementation for KAS Social Studies begins.

Professional Learning for Kentucky Academic Standards

Professional learning opportunities for the newly developed KAS will begin in March 2019. The Kentucky Department of Education has scheduled 16 regional sessions throughout the month of March to meet with district and school leaders. During these meetings, leaders will receive [links to the new KAS and virtual professional learning modules](#) as well as guidance to the development of district and school teams to facilitate the implementation of the new standards. In addition, weekly webcast will begin in April to continue the support for school and district facilitators. In June 2019, there will be three regional conferences for all educators to participate in learning sessions around their content. Once the 2019-2020 school year begins, regular virtual webinars will be available to leaders and educators.
