Millcreek PTA PTA President: Julia Craven □ Will hold regular scheduled PTA meetings and activities. □ Will advertise meetings and activities on school menus, school marquee, newsletters, and Millcreek website □ Will conduct elections of the PTA officers and SBDM Council parent members annually □ Will distribute information about parent involvement in PTA, SBDM and committees. □ Will advertise SBDM meetings on Channel 13.

Title 1 Title 1 Lead Teacher: Laura McCullough □ Will hold an annual meeting in the fall to inform parents of Millcreek's participation in Title 1 explaining instructional focus, requirements, and parent rights to be involved in school decisions. □ May allocate funds to pay parent involvement expenses including transportation, child care, or home visit expenses. □ Will hold Fall and Spring Title 1 Advisory meetings to review budget, current Parent Involvement Policy, School-Parent Compact, parent surveys, and parent meetings. □ Increase the sharing of responsibility between families and school through the Parent Involvement Policy and School-Compact. □ Will distribute a survey to parents for feedback on Parent meetings, Parent Involvement Policy, and Parent-School Compacts each February. □ Expect parents to attend at least ONE school-wide event and EACH Parent-Teacher or Student Led conference scheduled during the academic year.

Parent Communications Classroom Teachers/School Counselor □ Will be made available to all parents who wish to sign up for electronic mailing list. □ Will be sent home on a regular and timely basis to keep parents informed via memos, newsletters, phone calls, parent conferences etc. □ Will include at least ONE Home Visit prior to, or at the beginning of each year. Students who enter after the beginning of the year will receive a home visit within 30 days of entering the school □ Will be given to parents informing them of policies and procedures for Millcreek through the Parent Handbook

Parent Conferences Principal: Dr. Gregory Ross □ Will be conducted after 1st and 3rd grading periods for parents to receive test results and report cards. Parents are expected to attend. □ Will take place at a mutually agreed upon time and place. As a last resort these may take place by telephone or e-mail. □ Will include information about student proficiency levels that are expected in order to meet Kentucky's academic content and achievement standards, student assessments results, and description and explanation of curriculum used. □ Will be documented on the Millcreek Parent Conference Form and signed by all parties. □ Will include one annual student led conferences for students in grades 2-5. Parents are expected to attend. □ Will be made available to parents upon request or at the request of the teachers at any time.

Family Resource Center Family Resource Coordinator: Candace Tichenor □ Will hold meetings in cooperation with the district and state Family Resource Center to give parents opportunities to share experiences and participate in the education of their children. □ Will focus meetings on how parents can monitor their child's progress and work with teachers to improve achievement. □ Will encourage parents to serve as tutors, class readers, homeroom parents, chaperones (field trips), guest speakers, and presenters. □ Will require that any adult who volunteers in the school to complete a background records check.
