AGENDA APPROVAL:

BUDGET REPORT

School Activity Funds

SCHOOL IMPROVEMENT PLANNING

ESSER Funds

Mr. Thornsbury shared with the council the *TCMS ESSER Accountability Plan* to spend the allocated ESSER funds of \$522,000 over the next two years. ESSER funds are to provide direct services for student learning and to identify learning opportunities that accelerate learning and support needed for students disproportionately affected by the coronavirus and school closures. The school analyzed student achievement data to identify specific student needs.

The plan includes hiring a full time writing teacher as a nine week Encore class for all grade levels and increasing a math teacher position to full time.

In accordance with state and federal guidelines, assurances are required to engage in shared accountability of carrying out the plan. Along with the principal and the building leadership team, SBDM members are "guidance champions" of the school's *ESSER Accountability Plan*.

COMMITTEE REPORT:

Master Schedule

Mr. Thornsbury explained that after meeting with teachers for feedback and the timing of the conversation at the end of May, it was decided that there was not enough time to change the master schedule for the 2021-22 school year. However, the school will create an ad-hoc committee to review master schedule change options over the course of next year.

As for the 2021-22, the school will operate with the current bell schedule approved at the May 21, 2021 council meeting.
