SBDM Agenda was reviewed and approved by T. Sanford with a second from S. Kelly. Minutes with corrections were reviewed and approved with a motion from T. Sanford and a second form S. Kelly.

L. Caudill presented the Hybrid plan review with the committee. Below are questions that were asked during the review.

- T. Sanford How will we know if a student has medical exemption? Students will have to have an actual medical statement from a health care provider.
- T. Sanford How will teachers know who has medical exemption? As soon as school gets medical exemption on a student, that information will be passed onto that student's team and counselor. L. Caudill has also asked the district if there will be a parent note to be sent home to parents with students in the same class of a student with exemption. No response as of yet.
- T. Sanford Do we have back-up people in place to cover in case a teacher can not come back into the building? At this time, we do not have contingencies for supervision duties at this time. L. Caudill will make a note to come up with contingencies for locations.
- T. Sanford Is our school day going to be back the same way? District will add 10 minutes to the school day. It will be a staggered start in order to alternate our transitions.
- T. Sanford Clarification of new bus loop? We want to dismiss the buses one at a time in order to stagger students as they enter the building. We don't want a long line outside in case of the weather.
- L. Martin There is a 20 minute gap from walkers and car riders. Where do students go while waiting to enter the building? Teachers will be at their posts at 8:25. Walkers and car riders will line up on red dots that are placed outside along the sidewalk for social distancing and wait for their turn to enter the building.
- T. Sanford Cleaning of the classroom space, are teachers supposed to bring their own cleaning supplies? All cleaning supplies will be provided by the district. We do have an order placed. Teachers are asked to clean in between. Custodians and staff will assist in cleaning throughout the school day.
- T. Sanford Does our clinic provide COVID tests? Yes, you have to be symptomatic in order to receive.
- S. Kelly Will our onsite nurse still be coming out to check the kids? We have to get parent consent from all of our families so they will be able to go to the clinic. Our goal is to get 100% student consent. Any minor will be handled by office staff.
- T. Sanford How many students are allowed in a classroom at a time? There is no recommendation at this time like it is for targeted classrooms. Students will be split into 2 Cohorts.
- L. Patton How will the split affect the classrooms? (Classroom size vs. room size) L. Caudill is scheduled to meet with counselors tomorrow to look at student schedules. Answer to come soon.
- S Kelly With student meals being delivered to the classrooms, will students with allergies be taken into account? Yes

SBDM Committee went into closed session with a motion from T. Sanford and a second from S. Kelly at 6:44 pm. Committee returned from the closed session with a motion from T. Sanford and a second from S. Kelly at 6:49 pm.

L. Caudill reviewed the writing policy with the committee. Writing policy will be updated as Reviewed October 2020. L Caudill also reviewed the Consensus and Voting Rules Policy with the committee. This policy will also be updated as Reviewed October 2020 along with the correct date this policy was reviewed back in the Spring. There was no discussion.
